The City of El Paso's Department of Community and Human Development (DCHD) projects that the City will receive approximately \$10.3 million in federal grant funding for the upcoming 2023-2024 program year beginning September 1, 2023. The projected allocation is composed of the following four entitlement grants that are administered by the US Department of Housing and Urban Development (HUD): The Community Development Block Grant (CDBG), Housing Opportunities for Persons with AIDS (HOPWA), and the Emergency Solutions Grant (ESG). In addition, the allocation includes the Homeless Housing and Services Program (HHSP).

Below are the tentative schedules for the following DCHD programs – CDBG Services, ESG, HOPWA, CDBG Public Facilities and HHSP. Note that these schedules are tentative and subject to change due to various stakeholder needs. DCHD suggests contacting staff to confirm planning dates.
