Proposal Narrative Instructions

Please provide a clear, comprehensive description of your proposed project. Answer all Items below and include all information requested. The proposal narrative may be no more than 10 pages in length. The pages should be numbered. Text must be single-spaced, Times New Roman 10 point font, with a one-inch margin on all four sides. Please include section headings and item numbers (Example: Proposal Description / Project Summary followed by 1., 2., etc.). Submit your narrative as a pdf file along with your application form.

Proposal Description / Project Summary

- 1. How does the proposal directly address the following as indicated in the NOFA (page 3):
 - current community challenges housing + basic needs
- 2. Explain, In detail, how the proposal will address the key deliverable identified in the NOFA (page 5):
 - Provide mid to long-term permanent supportive housing (rental assistance and case-management services) to at least 20 veterans/veteran households that are: 1) economically impacted by COVID-19, and 2) experiencing homelessness. Proposals should prioritize veterans without access to VA benefits and other PSH programs, followed by veterans without access to VA benefits, but who do have access to other PSH programs.
- 3. Describe how your proposal will incorporate best practices as Indicated in the NOFA (page 5) and what model for those best practices will be used.
- 4. Describe how the proposal will address the immediate impact of COVID-19 with specific emphasis on how vulnerable veteran populations will be protected.
- 5. Describe how the proposal addresses the Program Characteristics + Guiding Principles as described in the NOFA (pages 4-5).
- 6. Describe how your proposal addresses the Required Program Components Identified in the NOFA (page 5).
- 7. Explain your agency's (and your partners' if applicable) history of performance under DCHD, State and Federal funding.

- 12. If portions of the proposal incorporate existing programs, explain how that program will be enhanced and provide added benefit to the community in terms of projected outcomes?
- 13. What other measurable outcomes will result from this project?
- 14. Describe how any additional services or support, not funded through this NOFA, provide additional benefits to clients of the program.
- 15. Explain how the project will be supportive of community wide goals to achieve functional zero homelessness for veterans.
