Property Tax Deadline Approaching

EL PASO, Texas—The City of El Paso Tax Office reminds taxpayers that the deadline to pay property taxes is quickly approaching.

The City of El Paso collects property taxes on behalf of all 44 taxing entities in El Paso County.

To avoid delinquent penalties and interest, payments must be received no later than **Friday, January 31, 2025**.
