Further investigation revealed that 20 cars were stolen from the property. The Auto Theft Task Force was assigned to the case. Within three hours of the investigation, police were able to locate ten vehicles throughout the city.

On December 3, 2024, police apprehended Banda and Saenz in connection with the auto thefts. Auto theft task force officers also located two additional stolen vehicles. Duckworth was identified as the person in possession of the cars at the time and was taken into custody. Police also tracked several vehicles in Juarez, Mexico. Auto Theft Task Force officers requested assistance from Mexican authorities, who identified two additional subjects, a 33-year-old female and a 35-year-old male, and took them into custody. Police were able to recover 15 vehicles within a two-day period. Five vehicles remain unaccounted for. The initial theft of the twenty cars was estimated at 675,000.00 dollars. The three arrested were charged with the above-listed offenses and booked into the El Paso County Detention Facility.
